<u>RES-2023-65</u> PH-County's Human Rights Law and Fair Housing Law

Tejash Sanchala identified small changes made within the law that included changes to definitions of terms such as intern and employer and military status.

There were inclusions of language to be more in line with state law that includes pregnancy related conditions, liberal construction, exclusivity and reasonable accomodation language.

Legislator Imamura asked about the addition of weight as a protected class as was done in New York City.

Mr. Sanchala explained that weight isn't currently being included but could be looked at in the future.

Legislator Imamura also asked about the specific exemptions of County employees being protected by the County's HRC Law.

Mr. Sanchala explained this being not a new change and its an effort to avoid conflict. County employees can find remedy at the state level.
