The guests shared their perspectives on affordable housing and what they consider are areas of improvement as well as successes. Some of the County programs that incentivize to build affordable housing are the Lands Acquisition Program – as it brings construction costs down, and Flex Funding – offering tax credits. A possible incentive for Westchester can be similar to a program established in New York City called limited equity co-ops, which includes specific financial needs requirements that facilitate ownership. The Welcome Home Westchester campaign also allows for developers to speak with local officials regarding home ownership as well. Zoning and process have been bigger issues that delay or prohibit the construction of these homes and in turn, create a bigger expense. Comprehensive plans can be an expensive undertaking but it can also help to bring the community and be considered for zoning. The Land Use Law Center runs a training program to bring municipalities into the conversation to collectively think creatively to build housing on available sites. Other concerns expressed include communities not wanting the impact on school districts due to increased student enrollments. Other suggestions made including ensuring to have inclusive affordable housing and even using County-owned properties to build affordable housing.
