This Bond Act is for the investigation, design and construction management for repair or replacement of the pipeline. Some of the issues seen include a blockage and a crack in the pipe which was repaired with an emergency contract in 2023. Water discharged into the Sound from this pipe is fully treated and clean water. Passing this item would help avoid future issues. Storm water is discharged by the municipality and if it falls into the facility then it is discharged through the storm water line. The Blind Brook plant is not a combined sewer system plant as in other areas.

This operational enhancement project request of \$850,000 is to replace the current infrastructure as it is aging and replacing it now will allow for continuity in operations. In 2023 the airport dispensed over 43 million gallons of jet A fuel and this project will allow for timely efficiency in delivering the fuel. Currently there is only one pump fueling and this project will serve as a back up to the current system. The lifespan is expected to be about the same, over 30 years. Designing will be in-house and construction will be placed for bidding.

The request of \$2,100,000 is the estimation for the entire project. This project passed the Type II SEQRA and also required a map change of their FAA airport layout plan as it triggers a national environmental analysis. In 2016 the United States Customs and Border Protection (CBP) requested from the County an independent facility including equipment and processing tools up to their current standards. This facility will bring the standard to federal regulations. Since this is a new building, they have a goal to make it as energy efficient as possible. The screening process at this facility is for general aviation passengers and flight crews crossing the international border inbound and plays a role for those heading outbound, not for commercial airlines. This project will also create a common-use deicing collection pad will be for general aviation on the west side, which currently does not have access to this important environmental resource. Currently about eight percent of the airport's deicing fluid – all from the aircraft on the west side of the airport - goes directly into the sewers.

This is a two-part project of \$5.3 million addressing the baggage handling (\$2.17 million) and the addition of a back-up generator (\$3.125 million). Baggage handling refers to commercial passengers' checked luggage and with the current system in place, there have been either delays in baggage arrivals for passengers and/or they travel on different flights. Funding for this project will improve baggage screening functionality as well as upgrading the electronic systems to function more efficiently. At this moment there is one back-up generator is undersized and shared with the parking garage. Although it is still in working condition, during an outage it does not give power to everything that is needed and in turn negatively affects
