MINUTES APPROVAL

I. ITEMS FOR DISCUSSION

1. 2024-170 HON. CATHERINE PARKER: ACT - Exchange of 13.4 Acre Parcel of County Property with Westchester County Joint Water Works

Guests: Law Dept.: Tami S. Altschiller, Assistant Chief Deputy County Attorney

Each of the committee chairs made opening statements. Legislation Committee Chair Smith explained what this legislation will do. He emphasized that the legislation does not finalize or execute the land exchange, nor does it ensure that the filtration plant will be built. He said it merely allows the County to negotiate and execute the land exchange, but does not ensure an outcome. Parks & Environment Committee Chair Tubiolo gave a history of what necessitated WJWW's request for the land exchange. Public Works & Transportation Committee Chair Pierce provided a history of the Board's review of the request by WJWW. She noted that all past meetings are available for review.

Legislator Pierce introduced a resolution to be considered in conjunction with the Act, and said the resolution emphasized the Board's commitment to limit development at the airport and protect the surrounding environment. She read the resolution into the record. The resolution provides in part that "Whereas, members of the community have conveyed concerns about unwanted expansion at the Airport; and Whereas, in order to protect the fragile environment surrounding the Airport, including drinking water for almost nine million people, from impacts such as noise, air and water pollution, the Board of Legislators adopted Resolution 245–2003 to manifest its intent to limit development of the Airport and now wishes to reaffirm its commitment to preserve current limitations on development at the Airport, subject to federal regulations such as requirements of the Federal Aviation Administration. Now, therefore, be it resolved that the parcel conveyed by WJWW to the County shall remain undeveloped except as otherwise required by federal laws or regulations."

Chair Smith noted that Legislator David Imamura had recused himself. Legislator Imamura previously submitted a memorandum stating: "As it concerns WJWW's request for County approval of the exchange transaction of a filtration plant in the Town of Harrison, I have consulted with the County Law Department and determined that it is necessary to recuse myself due to my law firm's representation of several involved parties. I hereby recuse myself from discussions, deliberations and decisions related to WJWW's request for County approval of the exchange transaction for construction of a filtration plant in the Town of Harrison." Mr. Nonna described the Brownfield Clean-up Program (BCP), and gave a history of why the Airport property entered the BCP. He discussed the New York State Department of Environmental Conservation's (DEC) role and oversight of properties in the BCP. He noted that the County has been working closely with the DEC to address the contamination and implement remediation measures. He further stated that the parcel to be transferred to WJWW will remain in the BCP and subject to DEC jurisdiction. For example, he explained that the County will have to file a change of ownership 60 days before the transfer occurs and then WJWW, as the new owner, will have to submit a change of use application subject to DEC approval. Mr. Nonna explained that DEC has authority to impose conditions and requirements it deems necessary.

Lisa Hochman, Legislative Counsel for the BOL, said that WJWW will have to obtain certain permits, approvals, and authorizations. She said that on a municipal level, the Town/Village of Harrison has to approve the site plan, and they have their own wetland regulations that would require permits, and a variance from the Zoning Board will also be required. At the state level, DEC will require compliance with BCP regulations as well as wetlands and discharge permits,

and the Department of Health and the Department of Transportation will likely require additional permits. Mr. Nonna noted that the Federal Aviation Administration (FAA) has no objection to the land exchange.

Several additions to the Act were proposed by Chair Pierce and discussed, including that: 1. the parcel acquired by WJWW will remain in the BCP and subject to jurisdiction and oversight by the NYS DEC.; 2. WJWW will file with DEC a change of use application for construction of the filtration plant subject to DEC approval and any conditions required by DEC; 3. WJWW will provide access to the County to perform its DEC/BCP requirements as well as for sewer connection; and 4. WJWW to indemnify the County for any claims arising out of the design, construction or operation of the filtration plant. Additional revisions to the committee report were proposed and discussed.
