# 2. <u>ACT-2021-208</u> BOND ACT(/Amended)-BIT32-Radio System Replacement

A BOND ACT (Amended) authorizing the issuance of additional bonds in the amount of ONE MILLION, ONE HUNDRED EIGHTY THOUSAND (1,180,000) DOLLARS in bonds of Westchester County to finance Capital Project BIT32 - Radio System Replacement.

Deputy CIO Harris discussed item # 2021-566-BOND ACT(Amended)-BIT32-Radio System Replacement. This amended bond act in the amount of \$1,180,00 will finance the continued acquisition and installation of equipment and systems necessary for the replacement of the County's emergency communications system. He advised that these systems, which include the Trunked Systems, the F1 and F3 Systems, and the radio component of the Computer-Aided Dispatch / Automatic Vehicle Location Systems, are used by first responders and other government personnel to ensure the safety of life and property and enable the delivery of vital services to the citizens of Westchester County.
