1. ACT-2022-78 IMA-County's Firing Range-Kent

Lieutenant Nick Alongi from the Department of Public Safety appeared before the Committee to discuss item #2022-310-IMA-County's Firing Range-Kent. He discussed that this IMA is similar to the agreements that we have with municipalities within the County, however since the Town of Kent is outside of Westchester County it needs separate legislation. What we gain from this at the County is that we are able to pull in instructors from other jurisdictions which enables us to diversify our Academy instructor staff. One of the instructors that we get from Kent is our main Defensive Tactics instructors, which are few and far between because it is a difficult certification to get. This saves the County a bunch of overtime since we are able to use him at the Academy.

2. <u>ACT-2022-76</u> <u>CBA-BIT49-Police Record Management System Upgrade</u>

AN ACT amending the 2022 County Capital Budget Appropriations for Capital Project BIT49 - Police Record Management System Upgrade.

Joint with PW&T. Guests: Lieutenant Michael Cindrich-Department of Public Safety CIO Marguerite Beine- DoIT Chief Information Offficer Beirne and Lt. Cindrich discussed the item. Legislator Shimsky said that a couple of sentences should be added to the committee report mentioning that we will be sharing this system with several local police departments. She also asked for a list of the departments that are part of the project. Lt. Cindrich said they are: Westchester County Department of Public Safety, the Town and Village of Mamaroneck, New Castle, Pleasantville, Mount Pleasant, Irvington, Tuckahoe, Rye Brook, Dobbs Ferry, Briarcliff, Lewisboro, Somers and Ossining. He said there are other departments that have expressed interest in it, but the pricing is based on the 14 agencies that are part of the project right now.

Legislator Shimsky asked if it will include reporting of hate incidents. Lt. Cindrich said the system will allow us to create tags for things like hate crimes. Ms. Beirne said the DA's office worked with IT to develop a portal to report on hate crimes as a stopgap measure to capture the information.

Legislator Shimsky noted that the committee report said the system will be purchased on or before April 10, 2024, but asked if there will be installation time. Ms. Beirne said the system will be ready to go then. Legislator Shimsky said we should change the wording in the committee report to "the project is expected to be completed by April 10, 2024."
