Mr. Ferris shared that the only thing that is changing is that the terms are expanding from 2 2-year terms to 4 2-year terms, to match with the Board of Legislators' elections and also allow for people to serve additional terms. He later added that the County Executive feels that this expansion would help those who are serving to contribute effectively to the on-goings of the board.

Legislator Smith asked if other boards have term limits and Mr. Ferris responded that for the most part they do not, however there are some appointments from the Board of Legislators that may have them.

Legislators Barr and Pierce expressed concerns that this board is the only one with term limits and Mr. Adin responded that the Parks Board also has term limits.
