Upon Chair Williams Johnson's introduction, Mr. Chen explained that this law would ban the sale or distribution of flavored tobacco products in the County. A few years ago New York State passed a similar law regarding vaping products but this law goes beyond that since they did not include other tobacco products. There are penalties that go from \$300 to \$1,000 for first offense and go up from there, multiple offenses can lead to a misdemeanor charge. This law is intended to penalize the retailers not the person in possession or the clerk. Similar legislation has been passed while also being contested in other areas which make this law achievable.

Dr. Amler spoke about popcorn lung and referenced that young people have had medical procedures to help remedy the health risks found. She also emphasized that unfortunately it will be years before there is concrete evidence of the impacts of vaping.

Dr. Gardiner provided information referencing how the African American community has been negatively impacted and targeted in the sale and promotion of cigarettes and e-cigarettes. He explained how the tobacco industry makes them financially accessible in predominately minority communities which confirm that they are in fact being targeted. Dr. Gardiner also added the efforts that he and his organization have done to circumvent this issue. He emphasized that this law should target retailers not the individuals carrying these items, as

well as how physically nicotine is more likely to addict people of color with higher melanin than others. Additionally, he mentioned the correlation between alcohol and smoking. Dr. Gardiner also dismantled the misinformation that impacting hookah products as it is currently used in this country goes against cultural practices; referencing the nicknames given to some of the flavors which are not relative to Middle Eastern cultures for example.

Mr. O'Flaherty provided input on the vaping and the risks involved in consuming these products. He clarified the misinformation that people who transition from traditional smoking to e-cigarettes and vapes. Vaping can lead to other products that can negatively impact public health. He also provided information on little cigars and the impact that they have on kids as well. Mr. O'Flaherty suggested that the terms "constituent" and "Reverse Preemption" be removed and the reasons why. Chairwoman Borgia expressed why she agrees with removing the "reverse preemption" paragraph by providing examples as well.

Ms. Durkee reiterated that enforcement should be on the retailer as opposed to the clerks and the individuals in possession of these items.

Ms. Cofer shared various points to keep in mind as the committee members address tobacco consumption issues. She outlined that there is no "safe" tobacco product, the percentage of cancer related deaths among smokers, the reduction of addiction levels that happen due to laws like this and promotes public health, to name a few. She added that the flavors in tobacco products draw them in and the nicotine is what keeps them in. Researchers found that there are several studies regarding FDA approved smoking cessation methods have positively impacted individuals. She referenced statistical information on the African Americans and the drastically low numbers of quitting. 26% smoking related deaths are cancer related, and this information is primordially based on the death certificates demographics. Dr. Gardiner added that 26% might be too low of a number because some people receive carcinogens from second and third hand smoke.

Mr. Summerfield added that removing the access to flavored tobacco products on a local level is very significant and in turn can positively impact other communities, which lead to action from larger entities and in turn reduce predatory practices.

Ms. Franco shared her organization's findings regarding tobacco related products and the impact of tobacco in Westchester County. She offered to connect Legislators to smoking cessation organizations and programming. Franco referenced connecting with the Department of Health regarding the CHIP and CHOW surveys. Mr. O'Flaherty added a reference to a smoking cessation program called "No Menthol, Know Why."
