### MINUTES APPROVAL

## I. ITEMS FOR DISCUSSION

Discussion on the impact of invasives on trees, such as ash and beech trees, in the County and on County properties.

Guests: Planning Dept.: Assistant Commissioner David Kvinge; Parks Dept.: First Deputy Commissioner Peter Tartaglia and Jason Klein, Director of Conservation; CE's Office: Peter McCartt, Director of Energy Conservation and Sustainability

*Chair Pierce noted that trees are under attack from invasives. She said that in 2011, research by the U.S. Department of Agriculture suggested that over 17 million trees will need to be replaced or replanted in communities in the U.S., and that number has increased since then. She noted that this is coming at a time when many of the trees planted at the same time are coming to the end of their lifespan. Since trees contribute shade, water and air filtration, and flood mitigation, we must deal with this problem. Trees also contribute to the beauty of the area, so there will be negative impacts to quality of life and tourism if we don't deal with this. Many areas are experiencing and will experience power outages and increased work for road crews as sick and dead trees continue to fall down. This can cause property loss, car accidents and injuries. We will need to budget for tree stock, removal of trees, and ongoing maintenance.*

*Assistant Commissioner Kvinge said the County works closely with the Soil & Water Conservation District on these issues. They have education and outreach programs on trees and tree maintenance. First Deputy Commissioner Tartaglia said that we have invasives growing everywhere, and an aging tree system within the County Parks Department. They build in tree replacement in any capital project they can, but it's not enough. They will need assistance in the future to replace trees.*

*Chair Pierce asked Mr. Klein to explain why our existing trees have not been able to propagate in sufficient numbers to maintain our existing tree canopy. Mr. Klein said that it is partly because of invasive species and partly because of deer. Chair Pierce asked if we will be able to get the tree stock we need. He said yes, but it is more an issue of funding because of the high cost of the trees. Chair Pierce asked if we have a guideline for the number of trees we will need or what the budget will be. Mr. Klein said no because we are experimenting with different methods.*

*Mr. Tartaglia discussed spotted lantern flies in orchard areas. Chair Pierce asked for information to provide to residents on what to look for on tree trunks. Mr. Klein said he will send it. Chair Pierce asked if there is a place where community members can report seeing spotted lanterns. Mr. Klein said there is a website and an app. Mr. Kvinge shared the following links: <https://www.dec.ny.gov/animals/113303.html> and <https://www.lhprism.org/>. Mr. Klein shared pictures of the spotted lantern fly.*

*Chair Pierce said the conversation will need to continue once we get a sense of the areas that will be hardest hit, and the budget needed to ensure that we get through the process.*
