### **ADJOURNMENT**

Your Committee recommends passage of "AN ACT reappointing Richard Wishnie as a voting director to the governing board of the Westchester County Health Care Corporation."

Your Committee is advised that in January 1997, the State of New York amended the New York State Public Authorities Law (hereinafter "Public Authorities Law") by adding a new Article 10-C, Title 1, thereby creating the Westchester County Health Care Corporation (hereinafter "WCHCC"). Article 10-C, Section §3303(1)(b), of the Public Authorities Law provides that WCHCC shall be governed by fifteen voting directors, of which eight directors shall be appointed by the governor and seven directors shall be appointed by the legislature of the County of Westchester, subject to the approval by the County Executive. See Public Authorities Law §3303(1)(b).

Your Committee is informed that Richard Wishnie, a member of the WCHCC Board of Directors, is completing a five-year term that expires on April 27, 2023. This ACT will reappoint Mr. Wishnie for a second five-year term to commence on April 28, 2023 and will expire on April 27, 2028.

Mr. Wishnie has outstanding qualifications which make his appointment to the WCHCC Board of Directors most desirable. Mr. Wishnie currently serves as a member of the WCHCC and has proven to be an insightful member of the Board.

Accordingly, your Committee encourages and urges the reappointment of Mr. Wishnie as a voting director of the WCHCC's Board of Directors. Notably, this is a legislative appointment, which is subject to approval by the County Executive. See Public Health Authorities Law §3303(1)(b).

Finally, as previously indicated, Mr. Wishnie is hereby appointed to a term of five (5)

years as a voting Director in accordance with Public Authorities Law 3303(3)(b), the term to

commence on April 28, 2023 and to expire on April 27, 2028.

Your Committee, after careful consideration, recommends the adoption of the

attached Act appointing Richard Wishnie to the Board of Directors of the WCHCC, subject

to approval by the County Executive, for a term to expire on April 27, 2023.
