#### Westchester County Structural Inspection Program

Performed structural inspection and evaluation of 19 pumping stations and five wastewater treatment plants, and numerous associated structures to identify structural deficiencies in the steel and concrete facilities. The inspections included visual observation and sounding of concrete elements. All inspections were conducted in accordance with ACI inspection standards. The facilities inspected included:

- Below-grade tanks grit removal, primary and secondary sedimentation, aeration, and disinfection.
- Above-grade tanks sludge thickeners, primary and secondary digesters.
- Superstructures process buildings, administration buildings, pump stations.

Inspections included identifying corrosion, cracks, section loss, misalignment, and other elements in need of repair. The repair of the deficient elements was prioritized based on risk of failure.

Cryders Lane Outfall, New York City - Responsible charge of all structural design for the Cryders Lane Outfall Modifications. This project involved the structural design for a concrete box culvert extension of an existing outfall. The new box culvert was designed to divert the outfall flow towards a diversion channel, where a floating netting system provides floatables control. Performed field inspection of existing concrete outfall to

assess its condition, coordinated soil boring services and performed structural design of the new precast concrete culvert.

Flood Protection, Johnson City, NY - Responsible charge of engineering services to perform an evaluation of flood protection alternatives that could be implemented at the Binghamton Johnson City Joint Sewage Treatment and the TPS. The alternatives studied included a flood barrier wall, watertight structures, submersible equipment and sump pumping improvements. The alternatives were evaluated against criteria for the level of protection for the plant facilities, compatibility with existing facilities, reliability of installation, maintenance requirements, impacts to plant operations and cost. The evaluation concluded that a flood barrier wall was the preferred alternative. The recommended project included approximately 2500 linear feet of steel sheet pile wall, backflow control gates on all outfall and drainage pipes penetrating the barrier wall, and a seepage pumping system inside the perimeter of the barrier wall.

## Biography of Joseph Barca
